Kuester moved and Smith seconded action on Resolution 2023-31, a resolution to amend previous resolution for Felix Grundy Days street closures, previously tabled from April 17, 2023. Council acknowledged Melanie Kirkpatrick, Felix Grundy Board Chair, and she explained the closure for F Avenue from 7th to 8th Street and 7th Street from E Ave to F Ave will be used for the car show. Kuester asked if F Avenue should be closed for both Friday and Saturday evenings. Kirkpatrick explained the Kiddie Parade has been moved back to Saturday, July 8th at 10am. Discussion was for the parking spots to be blocked during the Parade, the City may not have enough cones or barricades to do this. Smith moved and Lamp seconded action to amend the motion to include closure for F Ave from 7th to 8th Street for Saturday from 12noon through 1am Sunday, July 9th. No further discussion, motion carried five ayes.

Rasmussen moved and Kuester seconded action to approve to publish help wanted ad for open Police Officer position. Chief Waugh explained Officer Walters has submitted a letter of resignation and has accepted a position with City of Hudson. Chief Waugh also commented that Officer Walters has expressed interest in staying with our department as a Reserve Officer. No further discussion, motion carried five ayes.

Lamp moved and Kuester seconded action on the approval of Mayor's appointment of Dr. Clayton Edwards to the Library Board with term ending June 30, 2028; and Lauren Lamp to the Park Board with term ending December 31, 2023. No further discussion, motion carried four ayes (Lamp, Kuester, Smith and Rasmussen) and on abstain (Mcdonald).

Mayor Eberline opened the public forum at 6:40pm. Lindsey Freese, Kling Memorial Library Director, commented that the library was recipient of donation from GNB Bank and there is a new virtual tour of the library on their website. No further comments. Public forum closed at 6:42pm.

Finance Committee/Clerk commented on issues with federal reserve last week and all if fixed; Isaiah Corbin with INRCOG will be presenting at next meeting on WINVEST program with ISU students; and budget amendments.

Public Safety Committee commented on Officer Walters resignation and Officer Bradley has graduated from the academy; the recreation equipment program created by Officer Twyford is going over well with the community; and the 2015 Ford SUV is back on the auction as first buyer backed out.

Public Works Committee commented on water main project is moving along and lifeguards and manager position are still needed.

Smith moved and Rasmussen seconded adjournment of the meeting at 6:55pm. Motion carried five ayes. Next meeting will be Monday, May 15, 2023, at 6:30pm.
