Mayor Eberline introduced Eric Willis, Assured Partners, for a presentation on benefits and health insurance renewal. Willis commented that the City has received a decrease in health insurance premiums for 2024. Personnel Committee and Willis recommends renewing with Wellmark with current policies and health savings account benefit amounts. Discussion was held on increasing life insurance and short/long term disability benefits. Currently City offers \$10,000 life insurance policy for the employee; \$10,000 for employee AD&D; dependent life and child policy. Willis collected an estimate for increasing life insurance and AD&D to \$25,000 per employee with The Standard for an addition \$800 per year. Discussion was also held on short- and long-term disability policies, which the City does not offer at this time. However, the employee paid may be an option. Smith moved and Mcdonald seconded action to discontinue the life insurance with Dearborn National and sign on with The Standard policy for City paid life insurance to be increased to \$25,000 per employee. No further discussion, motion carried three ayes (Smith, Mcdonald and Kuester) and one abstain (Rasmussen).

Mcdonald moved and Smith seconded action on Resolution 2023-79, a resolution to approve the contract for services for health insurance coverage with Wellmark for calendar year 2024. No further discussion, motion carried three ayes (Mcdonald, Smith and Kuester) and one abstain (Rasmussen).

Rasmussen moved and Kuester seconded action on Resolution 2023-75, to approve a BIG Grant for Jill Krausman, IA Landmark Properties, LLC, 805 G Avenue for façade repairs and overhead doors, previously tabled. No further discussion, motion carried four ayes.

Kuester moved and Rasmussen seconded action on Resolution 2023-80, a resolution amending Resolution 2023-78 previously accepted bid on the City Hall steps and retaining wall project. Kuester commented that reference and pictures received did not show the work the City is needing accomplished and also explained the process given by Precision Landscape involving digging back 3-4 feet closer the building to tie the landscaping block back with geogrid material. No further discussion, motion carried to four ayes.

Mayor Eberline opened discussion on hiring for vacant police officer position and possible take action to publish help wanted ad. Chief Twyford explained the previous ad had expired and the need to hire the fifth officer that was budgeted is still there. Chief Twyford explained to start the testing process we need to advertise for applications and hold interviews. Discussion was held on police department budget regarding vehicle repairs and larger expenses. Smith moved and Mcdonald seconded action to proceed with publishing the help wanted ad for the vacant fifth police officer position. No further discussion, motion carried four ayes.

Mayor Eberline opened the public forum at 7:06pm. No public comments, public forum closed at 7:07pm. Finance Committee/Clerk commented on election day tomorrow, November 7, 2023; City Hall closed on Friday,

November 10, 2023, for observance of Veterans Day; and upcoming work session for TIF training with Maggie Burger, Speer Financial.

Public Safety Committee commented on uptick in mental health related calls in the last week.

Public Works Committee commented on the rate survey from Clapsaddle Garber & Associates, Inc, continuing with tree removal and curbside leaf pickup.

Smith moved and Rasmussen seconded adjournment of the meeting at 7:15pm. Motion carried four ayes. Next meeting will be Monday, November 20, 2023, at 6:30pm.
