Mayor Eberline acknowledged Jean Garaventa and thanked her for her 26.5 years of service with the Grundy Center Police Department and the City of Grundy Center and congratulated her on her retirement. Chief Twyford spoke on Garaventa's skill and expertise in assisting the department and leading in the right direction.

Mayor Eberline acknowledged and introduced Jennifer Schwartz, owner of Rapha Reins. Schwartz presented a request for use of city streets to host a 5K run as a fundraiser for her nonprofit organization, Rapha Reins. Rapha Reins is an equine therapy center which focuses mostly on mental health therapy for teenagers and adults. Rasmussen moved and Mcdonald seconded action on approval to use the city streets on June 15, 2024, from 8am – 12noon for the 5K run. No further discussion, motion carried five ayes.

Lamp moved and Rasmussen seconded action to approve an annual liquor license for JR Kennedy, Gatsbee's, 404 6th Street, Grundy Center. JR Kennedy, owner of Gatsbee's, explained that his business will have a similar feel as a speakeasy bar from the 1920's era. Hours plan to be Tuesday-Saturday, 4pm-10pm, with occasional special events. Frank Lamp, Gary Meyer, Pam & Curt Mauer, all concerned neighbors spoke of parking, capacity, loud music, etc. E. Lamp commented that the city Code of Ordinances requires one parking space per one hundred sq foot of the business, will this be able to accommodate? No further discussion, motion carried five ayes.

Smith moved and Lamp seconded action to open the public hearing at 6:57pm on the sale of real property and conveyance of real estate to the Iowa Department of Transportation for the Highway 14 Bridge project. Mayor Eberline explained this real property consisting of the very east end of Mill Street ditch close to Manatts, which is city right of way. No public comments. Rasmussen moved and Kuester seconded

action to close the public hearing at 6:59pm. No further discussion, motions carried five ayes. Rasmussen moved and Lamp seconded action on Resolution 2024-34, a resolution to authorize Mayor Eberline and Clerk Sawyer to sign documents needed to sell real estate property and deliver of conveyance by a guit claim deed to the Iowa Department of Transportation for the Highway 14 Bridge project. No further discussion, motion carried five aves.

Smith moved and Mcdonald seconded action on Resolution 2024-35, a resolution to authorize Mayor Eberline to sign a contract with Axon Enterprise, Inc. for the police department dash cameras. Chief Twyford explained this contract is for two dash cameras, the new squad, and the used Ford SUV squad. Kuester guestioned the amount of storage and why only two cameras. Twyford explained the Taurus squad will soon be the back up car and can continue to use what we have for the time being and clarified the storage is unlimited. No further discussion, motion carried four ayes (Smith, Mcdonald, Lamp and Rasmussen) and one nay (Kuester).

Mcdonald moved and Smith seconded action on Resolution 2024-36, a resolution to accept a letter of resignation from Alissa Twyford, Police Chief effective July 31, 2024. Mayor Eberline thanked Twyford for her commitment and hard work put into this position. Twyford plans to finish her college education and has been offered an opportunity with the United States Forest Service. No further discussion, motion carried five ayes.

Mayor Eberline opened the discussion on Police Chief position and possible take action to publish help wanted ad. Mcdonald commented for Council to take time to fill this position. Eberline commented, with advice from City Attorney, on splitting the Chief position is unwise due to the Chief duties in the Code of Ordinances. Eberline requested input from Public Safety Committee and Council, however urges the Council to approve the help wanted ad to start the hiring process by collecting applications. Smith moved and Mcdonald seconded action to publish a help wanted ad for the Police Chief position. No further discussion, motion carried five ayes.

Mayor Eberline opened the discussion on the FY2024 budget amendments. Clerk Sawyer explained the amendments to both revenues and expenditures. Rasmussen moved and Smith seconded action to approve publishing for the public hearing on Monday, May 20, 2024, for the FY2024 budget amendments. No further discussion, motion carried five aves.

Mayor Eberline opened the public forum at 7:18pm. Gary Meyer, 1302 9th Street, commented on parking along M Avenue and 12<sup>th</sup> Street, many students parking there and public us unable to make a turn from M Avenue to 12<sup>th</sup> Street. No further comments, public forum closed at 7:20pm.

Finance Committee/Clerk commented on new pool pass procedure.

Public Safety Committee commented on the GTSB Grant as receiving \$5500 towards overtime, education, and new radar unit.

Public Works Committee commented ceiling repairs in City Hall now that roof project is complete; planting thirty-eight new trees from the grant received from Grundy County Community Foundation; and purchasing rescue tubes, freezer, pool pass software, equipment, and cards for passes with grant funds from the 100Women grant.

Rasmussen moved and Mcdonald seconded adjournment of the meeting at 7:30pm. Motion cafive ayes. Next meeting will be Monday, May 20, 2024, at 6:30pm.
