Kuester moved and Mcdonald seconded action on the Third Reading of Ordinance 575 - Water Rates, an ordinance amending water rates by 2% effective July 1, 2024. No further discussion, motion carried five ayes.

Rasmussen moved and Lamp seconded action on the Third Reading of Ordinance 576 – Sewer Rates, an ordinance amending sewer rates by 2% effective July 1, 2024. No further discussion, motion carried five ayes.

Smith moved and Rasmussen seconded action on the Third Reading of Ordinance 577 – Fireworks, an ordinance to amend the allowable dates and times for exploding fireworks within the City limits. No further discussion, motion carried five ayes.

Mayor Eberline acknowledged Dwight Gliem, EMS Director, for a presentation on an end of the fiscal year update on the ambulance department. Gliem commented that ambulance 500 continues to have

many maintenance issues and will continue putting more money into it. Plan is to list it on Govdeal.com as soon as possible. New rig that is on order has an estimated delivery date of December 1, 2024. Staffing is going well, Paramedic deployed with the military right now should be returning in December. Gliem mentioned the department is extremely fortunate to have 26 dedicated volunteers to assist in keeping the ambulances running. Kuester questioned what the percentage is that Physician Claims Company charges when doing the ambulance department billing, Gliem commented 8% of all billing collections is paid to PCC. Smith questioned the decrease in call volume for this year, Gliem answered that Gladbrook-Lincoln Ambulance coverage dropped from 7days to 4 days a week for coverage about a year ago. No further discussion, no formal action taken.

Mcdonald moved and Smith seconded action on Resolution 2024-44, a resolution authorizing the annual wages for employees effective July 1, 2024. Smith moved and Mcdonald seconded action to amend the motion to authorize a 10% wage increase to police and ambulance departments and a 5% increase for other remaining employees for fiscal year 2025. Eberline commented that difficult discussions were held, and City wants to give employes the best package possible. No further discussion, motion carried four ayes (Mcdonald, Smith, Lamp, and Kuester) and one abstain (Rasmussen).

Rasmussen moved and Lamp seconded action on Resolution 2024-45, a resolution to authorize a dissolution of Chapter 35 Police Department ordinance and pursue a 28E agreement with the Grundy County Sheriff's Office. Smith expressed he wanted one more chance at allowing our police department to remain due to the overwhelming support from public during open meeting. Discussions that a market wage adjustment is necessary and down the road things may need to change. Mcdonald also mentioned the strong feelings from residents the keep "our" police department. Eberline commented that everyone is aware that changes need to be made. No further discussion, motion failed two ayes (Kuester and Lamp) and three nays (Mcdonald, Smith and Rasmussen).

Lamp moved and Smith seconded action to approve provide a letter of support for the Chamber Main Street Challenge Grant application for Luke & Crystal Davis, owners of South Porch Cider Co., 625 & 627 G Avenue, Grundy Center. Davis spoke of purchasing the previous Hallmark building and the grant will be used to update the façade, roof, main floor commercial space and upper story apartments. No further discussion, motion carried five ayes.

Mayor Eberline opened the public forum at 7:05pm. Nic Simwell introduced himself as the new business owner opening a faith-based tattoo business, Waymaker Ink, at 612 7th Street, Grundy Center. Emory Bunkers thanked Council for decision made during this meeting. No further comments, public forum closed at 7:09pm.

Finance Committee/Clerk made no comments.

Public Safety Committee made no comments.

Public Works Committee commented on collecting bids on pool painting project.

Smith moved and Lamp seconded adjournment of the meeting at 7:15pm. Motion carried five ayes. Next meeting will be Monday, July 15, 2024, at 6:30pm.
